COOKIE POLICY

1. IDENTITY OF THE DATA PROCESSOR

INKA CROPS S.A. (hereinafter, "INKA CROPS") with Tax ID No. 20291939083, located at Av. El Santuario No. 1127 – Urb. Zarate, district of San Juan de Lurigancho, Lima – Peru, is the data processor responsible for the processing of personal data collected through the use of cookies on its websites.

3.- WHAT DO WE USE COOKIES FOR?

We use first-party and third-party cookies to:

- Ensure the technical and secure functioning of the site.
- Analyze and optimize performance and browsing experience.
- Remember your preferences, such as language or region.
- Offer personalized content and advertising, only when prior consent has been provided.

INKA CROPS does not collect information that directly identifies you. All information obtained through cookies is processed in anonymized or pseudonymized form.

Such data may be stored in INKA CROPS S.A.'s Personal Data Bank "Website Users," duly registered with the National Authority for Personal Data Protection, and will be processed in accordance with Law No. 29733 and its regulations

8.- DATA HOLDER RIGHTS
